## Policy

Please read through and initial each policy subject. A copy will be given to each family for their records.

### Tuition

1. Tuition is due on the 1<sup>st</sup> of every month. If tuition has not been paid by the 7<sup>th</sup> of the month then a late charge of \$15 will be assessed to your account. \_\_\_\_\_
2. All account and billing inquiries must be addressed to the office staff, and not directly to the student's teacher. \_\_\_\_\_
3. All students who are dropping classes must fill out a DROP Form, and give to the office staff by the 2<sup>nd</sup> week of the month. If Dance Fusion is not notified of dropped classes, the tuition will still be charged to your account. \_\_\_\_\_
4. If you are enrolling in the middle of the month the 1<sup>st</sup> month tuition will be pro-rated. \_\_\_\_\_
5. If any classes are missed you may arrange to schedule a make-up class. Make-up classes must be completed while your child is actively enrolled. There will be no refund for any classes missed. \_\_\_\_\_

### Facility

1. Dance Fusion is not responsible for the comings and goings of child before and after the dance class. It is the responsibility of the dancer's parent/guardian to see that child arrives and leaves dance facility safely. **If your child requires special attention to ensure his/her safety, parent/guardian will notify instructor that day and request that the child be signed in and out.** \_\_\_\_\_

### Studio & Waiting Room Etiquette

1. Dancers must come to class fully prepared for dance class. \_\_\_\_\_
2. NO street shoes in the dance studio. Only proper dance shoes stated in Dress Code. \_\_\_\_\_
3. Only water is allowed in the dance studios. Food allowed only in dancer area. \_\_\_\_\_
4. All dance bags are to be placed in the back room, not left in the studio or waiting room. \_\_\_\_\_
5. Dance Fusion is not responsible for any lost or stolen items. \_\_\_\_\_
6. If a dancer is injured in class, or in the waiting room, they must immediately notify the teacher or the office staff. \_\_\_\_\_
7. Parents must wait for their children in the waiting room. Please do not "signal" your dancer in class. (Dance Fusion will have two parent observation weeks.) \_\_\_\_\_
8. There will be no running, screaming, or horsing around both in the dance studio and waiting room area. \_\_\_\_\_

  - A. Recital Costume Fee \$60.00 per costume/per dance (unless otherwise stated) **due on or before November 1 and/or April 1 each year** \_\_\_\_\_
  - B. Recital Fee \$40.00 per dancer **due on or before November 1 and/or April 1 each year.** \_\_\_\_\_
2. All Dress Rehearsals for Recital and other performance rehearsals are mandatory. \_\_\_\_\_

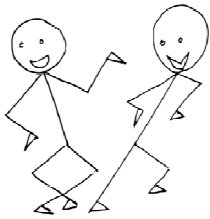

**What You Grant by Signing this Form:**

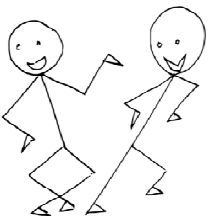
